## CONDITIONS OF MEMBERSHIP

The following information is for the advice off all prospective members. This information contains details of the obligations and requirements accepted by all members with regard to the payment of annual subscriptions, renewal of and resignation from membership and the penalties that may result from failure to follow the guidelines. No membership application will be processed unless the signature of the applicant appears to acknowledge that they have read and fully understood these terms and condition.

### **1. APPLICATION FOR MEMBERSHIP**

I understand that if accepted for Membership, I will abide by the Constitution and Rules of the Tasmania Golf Club, and will be held accountable for all monies owing to the Club, relating to my subscription, from the date of acceptance, and any costs incurred by the Club in recovering any outstanding subscriptions or other costs in line with my obligations under the constitution until such time as I tender my written resignation.

I understand that, notwithstanding any further information I may receive, my application for membership or any subsequent application to transfer to another category of membership is not fully approved until such time as it has been presented to a meeting of the Board. Under normal circumstances, the application would be presented to the next Board Meeting after receipt of the application.

I understand that when this form, duly completed, is received by the Club along with the Nomination Fee which applies to the category for which membership is sought, I may play without payment of green fees and may play in competition fields to enable me to return five cards for handicap purposes. I understand that, should this application be refused, this amount will be refunded in full.

#### **The following clauses of the Constitution are relevant to member applications:**

- 5.7 Upon a nomination being approved by the Board, the General Manager shall:
  - 5.7.1 with as little delay as possible, notify the nominee, in writing, that the nomination for membership has been approved, the sum payable by way of subscription and the date by which it is to be paid.
  - 5.7.2 enter the person's name in the register of members.
- 5.8 If a person who has been notified in accordance with subclause 5.7.1 fails to pay the subscription in full by the date referred to in the notice under subclause 5.7.1 the Board may revoke the approval of the nomination.
- 5.9 Once a member has been accepted into a specific category of membership, as confirmed by the notification supplied under clause 5.7.1, the member, except at the written direction of the Board, shall remain in that category for that playing year and shall liable for the full subscription for that category.

### **2. RENEWAL OF MEMBERSHIP**

#### **The following clauses of the Constitution relate to renewal:**

- 5.10 Subject to the provisions of this Constitution, at the start of each playing year every member shall be automatically accepted into the same membership category held immediately before that playing year and, except at the written direction of the Board, shall remain in that category for that playing year and shall be liable for the full subscription relative to that category unless;
  - 5.10.1 they have resigned in writing; such resignation to be received by the Club before the expiration of one month after the start of the playing year; or
  - 5.10.2 they have applied, in writing, to the Board for transfer to another playing Category and this application has been approved; such application to be received by the Club before the expiration of one month after the start of the playing year;
  - 5.10.3 For in the case of a Member who was a junior Member immediately before the new playing year their category of membership alters due to their age.
- 5.11 For the purpose of these rules, if a Member utilises their membership after the start the playing year, they shall be taken to have renewed their membership in accordance with these rules and become liable to pay their subscriptions accordingly.

### **3. RESIGNATION FROM MEMBERSHIP**

#### **The following clauses of the Constitution relate to resignation:**

- 9.1 A member of the Club may, at any time, resign from the Club by delivering or sending by post to the General Manager a written notice of resignation.
- 9.2 If a member who has not utilised their membership since the start of any playing year resigns, after the expiration of one month but before the expiration of three months from the start of the playing year, they shall be liable to pay the Club the equivalent of one half of the current subscription amount payable for the category in which they were a member immediately before the start of that playing year.
- 9.3 If a member fails to resign from, or renew, the membership is set out in these rules within three months after the start of the playing year they shall be removed from the membership register and shall be liable to pay the Club the equivalent of one half of the current subscription amount payable for the category in which they were a member before the start of that playing year.
- 9.4 For the purposes of these rules, if a Member utilises their membership after the start of a playing year, they shall be taken to have renewed their membership in accordance with these rules and, except at the written direction of the Committee, become liable to pay their subscriptions accordingly.
- 9.5 Upon receipt of the notice of resignation the General Manager shall remove the name of the member from the register and the member shall cease to be a member of the Club.
